CANCELLATION AND PENALTIES POLICY

(for individual guests)

[1] Cancellation policy:

I. Accommodation

Conditions:

- ❖ Minimum 14 days before arrival: can be canceled free of charge
- At least 7 days before arrival: a penalty must be paid
- ❖ In case of cancellation within 7 days: a penalty is payable

Exceptions:

Cancellation due to force majeure (death of a guest, death of a relative, etc.): in this case, we waive the penalty. However, a certificate (medical certificate or hearing certificate) required! Failing this, it is payable according to the rules we are fined.

II. Other services

Conditions:

- ❖ At least 7 days before the day of using the service: 0% penalty for all services
- ❖ In case of cancellation within 7 days (including on-site cancellation): a penalty rate of 0% or 100% depending on the nature of the service²

[2] Penalty:

I. Accommodation

Penalty base: The penalty base is the accommodation fee, which is equal to the amount of accommodation + breakfast, and when booking a package with the full amount of the package. Other, separately booked and paid services are not included in the penalty base.

Penalty rate: 0%, 50% or 100% of the penalty base depending on the date of cancellation
